6. MAYOR'S REPORT

Mayor Rogero remarked on the recent passing of former City Council Member Raleigh Wynn, Sr. She reflected on his life and work as an educator and coach in this community. The Mayor offered the City’s condolences and sympathies to his family.

Kaye Graybeal presented her report to the Mayor and Council. Following this presentation, there was a discussion between Council Member Brown and Kaye Graybeal concerning Knoxville College and whether the buildings on its campus are protected from demolition on account of its historic designation.
